






## **Vital Few**

# **Shared-Use Nonmotorized (SUN) Trail Program**

- Section 339.81, Florida Statute, established the program in 2015
- \$25 million annually funded from the redistribution of new vehicle tag revenues
- To develop a statewide system of paved non-motorized trails for bicyclists and pedestrians (SUN Trail network) that are a priority established within the Florida Greenways & Trails System, Chapter 260, Florida Statute



People are more likely to shift from driving to bicycling if they feel safer and more comfortable in their environment.

Commuting Trends in Florida, Florida Department of Transportation (2016)
















## **Coast to Coast Trail**

- A developing 250-mile regional trail system spanning nine counties through Central Florida
- When complete it will connect Tampa Bay and the Gulf of Mexico to the Atlantic Ocean
- Over 180 miles of existing trail, in segments
- Multiple construction and preconstruction projects underway
- More than \$29.5 million programmed in the FDOT Five-Year Work Program through fiscal years 2023/2024

# **Starkey Trail**

The Shared-Use Nonmotorized (SUN) Trail program provided nearly \$2.8 million for this construction project, formerly known as the Starkey Gap – now the Starkey Trail. It completes Pasco county's last link of the Coast to Coast Trail (C2C). The developing C2C regional system will connect communities and destinations through Central Florida from the Gulf of Mexico to the Atlantic Ocean. Today, bicyclists and pedestrians may begin at Demens Landing Park in downtown St. Petersburg, and journey over 80 miles along the C2C to Hernando county's Suncoast Trail, and beyond; another 100 miles of the C2C exists in segments to Titusville.

The Starkey Trail closes the 2.4-mile gap between the segment along Starkey Boulevard in the community of Trinity and the Tri-County Trail at the Pasco and Pinellas county line. A portion of the project is along a Duke Energy (an electric power company) high-tension utility line. Public-private partnerships offer promising opportunities for furthering trail connectivity. The

Established during the 2015 legislative session and administered by the Florida Department of Transportation, the SUN Trail program receives an annual allocation from the redistribution of new vehicle tag revenues to expand the statewide system of paved multi-use trails (SUN Trail network) for bicyclists and pedestrians. The SUN Trail network is a refined version of the Florida Greenways and Trails System Plan's Land Trail Priority network. This project improves Florida's transportation system. It enhances access between community features including businesses and natural areas.








# St. Johns River-to-Sea Loop – a complimentary route of the ECG

#### SUN Trail Funding Fact Sheet **Dale Avenue Trail**

In just over a year from proposing the project, the city of Edgewater was host to the first ground breaking and subsequently the first opening of a Shared-Use Nonmotorized (SUN) Trail funded construction project. Extending from the intersection of Dale Avenue and West Park Avenue, north to 10th Street, this 1.2mile project provides transportation options around Daytona State College's New Smyrna/Edgewater Campus, and New Smyrna Beach Middle and High Schools. The bridges crossing the Turnbull Hummock are highlights of this nearly \$1.1 million project. The city of Edgewater manages this trail which connects to the East Central Regional Rail Trail.

The Florida Department of Transportation completed design and construction of a 12-foot-wide Shared-Use Nonmotorized (SUN) Trail funded project along the east side of U.S. 17 (also known as State Road 15 and North Center Street) from Washington Avenue to Palmetto Avenue, to coincide with opening the elementary school in August 2018. Implementation of this trail addresses a need identified in the 2008 Pierson/Seville Elementary School Bicycle and Pedestrian Safety Study. The project extends just over one-mile from the school, south past the Municipal Airport, and connects to the sidewalk on Washington Avenue, which provides access to the Volusia County's Votran Bus Route (Pierson/Seville) and to the baseball fields at Nixon Park on Chipper Jones Lane. The \$1 million trail gives students an opportunity to increase their physical activity by walking or bicycling between their homes, the school

# **East Coast Greenway**

## **Timucuan Trail**

Visioning for the Timucuan Trail began over 20 years ago. The first trail segment opened along Little Talbot Island in 2005. Local, state, and federal government and nonprofit partners continue using multiple funding sources to implement the vision for connecting culturally rich and ecologically diverse resources along Florida's northeast coast. Most recently the Shared-Use Nonmotorized (SUN) Trail program provided over \$3.1 million for the construction of a half-mile trail extension and bridge crossing Haulover Creek. Located along State Road A1A, also known as Heckscher Drive, this SUN Trail project extends the Timucuan Trail near Ft. George Island Cultural State Park to the city of Jacksonville's Huguenot Memorial Park.

Established during the 2015 legislative session and administered by the Florida Department of Transportation, the SUN Trail program receives \$25 million annually, from new vehicle tag fees, to expand the statewide system of paved multi-use trails (SUN Trail network) for bicyclists and pedestrians. The SUN Trail network aligns to the statewide Florida Greenways and Trails System Plan's Land Trail Priority network. This project improves safety and mobility while enhancing access to Florida's unique resources.


